Product replacement is our only responsibility, and your only remedy, for breach of warranty as a result of a defect in the product. Textured Coatings of America, Inc. shall have no responsibility to apply the replacement product, or to pay for or contribute to the cost of labor for such application.

THIS WARRANTY DOES NOT COVER DISCOLORATION OR DAMAGE RESULTING FROM SETTLING OF THE BUILDING, MAJOR BUILDING MOVEMENT, CRACKING, ROOF LEAKS, ROOF RUN-OFF, SPRINKLERS, ACTS OF GOD (E.G., WIND STORMS, HAIL, FLOOD, HURRICANE, TORNADO, EARTHQUAKE), MECHANICAL OR EXTERNAL PHYSICAL CAUSES, OR ANY LEACHING OR BLEEDING THROUGH OF CONTAMINANTS FROM THE UNDERLYING SURFACE TO WHICH THE PRODUCT IS APPLIED. THIS WARRANTY DOES NOT COVER ANY PRODUCT APPLIED OVER WOOD-FIBER COMPOSITE HARDBOARD SIDING. This warranty only covers product applied to single-family residences. Apartments, condominiums, multi-family dwellings and commercial use are excluded. This warranty also does not cover the portions of the product applied to fascia boards, entry, exit and garage doors, trim and/or any movable surfaces. This warranty will be effective only if the product has been applied in accordance with our specifications, and does not cover failures of the product caused by improper preparation of the surface, including but not limited to, failure to remove old layers of paint, or failure to sand, scrape and/or replace all rotted wood, prior to the application of the product.

This warranty is transferable one (1) time, if transferred to a purchaser of your home within three (3) years after the Date of Application of the product, and is otherwise extended only to the original purchaser of the product. Written notice of the transfer of this warranty must be given to us within thirty (30) days of the sale of your home.

We make no other express warranties to consumers. The terms of this warranty are not subject to modification. The sales representative and/or contractor is not our agent or employee, so any additional promises or warranties made by the sales representative and/or contractor are not our responsibility.

WHETHER ANY CLAIM IS BASED ON NEGLIGENCE OR OTHER TORT, BREACH OF WARRANTY OR OTHER BREACH OF CONTRACT, OR ANY OTHER THEORY, IN NO EVENT WILL WE BE LIABLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES INCLUDING BUT NOT LIMITED TO LOST PROFITS, LOSS OF USE OF A HOME OR OTHERWISE.
